Course description

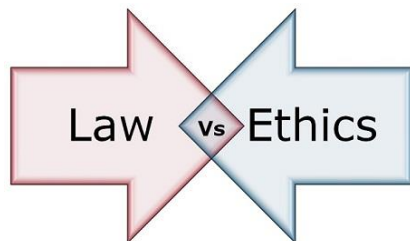
The course deals with psychological, ethical and legal issues in prenatal genetic testing, cancer genetic testing and reproductive genetic testing, and problem of confidentiality.
